**WRIT DENIED.**

The applicants, John Gentry and Diana Gentry, d/b/a Richland Parish Farm Partnership, seek supervisory review of the portion of the trial court's August 26, 2024,

judgment sustaining the exception of lack of subject matter jurisdiction filed by Northeast Louisiana Electric Power Cooperative, Inc., and dismissing the applicants' claims against it. The August 26, 2024, judgment sustaining the exception of lack of subject matter jurisdiction is a final and appealable judgment. La. C.C.P. arts. 1841 and 2083.

Applicants advise that they have already moved for a devolutive appeal of the entire August 26, 2024, judgment. Accordingly, the writ is denied. The applicants' claims will be considered under the Court's appellate jurisdiction in due course after the applicants' requested appeal has lodged in this Court.
