## WRIT GRANTED AND MADE PEREMPTORY; REVERSED; REMANDED.

The applicant, State of Louisiana through the Board of Supervisors of Louisiana State University and Agricultural and Mechanical College, seeks supervisory review of the trial court's ruling granting "Plaintiff's Dilatory Exception of Improper Use of Summary Proceeding." We find that the trial court erred in granting the exception. A motion to enforce a settlement agreement is triable in a summary proceeding. *Howard v. Louisiana Citizens Prop. Ins. Corp.*, 10-1302 (La. App. 4 Cir. 4/27/11), 65 So. 3d 697; *Banque De Depots v. Bozel*

*Mineracao E Ferroligas*, 98-0742 (La. App. 4 Cir. 1/27/99), 728 So. 2d 533, *writ denied*, 99-0557 (La. 4/23/99), 742 So. 2d 882. Accordingly, this writ is granted, and the trial court's ruling is reversed. This matter is remanded to the trial court for further proceedings.

Pursuant to La. R.S. 13:4521, the temporarily deferred costs of this writ application, in the amount of \$182.00, are assessed against Alshymaa Y. Hassan.
